ATTENDANCE

More House School is dedicated to supporting strong attendance for students so that they receive an excellent education as the benefits of being in school are numerous. Therefore, we are committed to reducing absence from School and recognise that this challenge cannot be met by the School alone.

What YOU must do:

Try to telephone the school before 8.25am
each day of your child's absence. If no
contact is made by 8.45am, a text message
will be sent to parents/carers asking them to
contact the school and provide a reason for
the absence.

- Tell the school in advance of any medical appointments and bring in or email appointment cards/letters.
- If you are not sure whether your child is well enough to attend school, send them in anyway as they often perk up on arrival.
- If you and your child are experiencing difficulties with school attendance then talk to us as a first step so we can help!

What WE will do:

- Check your child's attendance every day.
- Phone home to discuss your child's attendance with you.
- Invite you into school for attendance meetings if we are concerned.

PUNCTUALITY

Having good attendance also means being on time and not being late to school. Students who arrive late can feel embarrassed, left out and miss out on important introductions to lessons. Punctuality is an essential life skill that needs to be taught from the very beginning.

Please ensure that your child arrives at School on time so that they are present for registration; this takes place at 8.25am each day.

Lateness causes problems over register marking and missed instructions. Where a genuine reason for lateness exists, this will be an 'authorised absence' but where explanations are inadequate or the lateness is after 8.55 a.m. then an 'absence from registration' will be recorded.

MEDICINE IN SCHOOL

A reminder that in order for us to safely administer medication in school, we require a Parental Agreement to Administer Medication form to be filled in and returned to the school with any medication to be given to your daughter.

If your child suffers from asthma and/or uses an EpiPen there is also a form for you to complete. For

asthma, the school must be given a spare inhaler whilst your child should carry one with them at all times; the completed form should be accompanied by a copy of your child's Asthma Plan. For severe allergies, the school should be given 2 EpiPens as well as a copy of your child's Allergy Action Plan.
